**Description of necessary first aid measures**

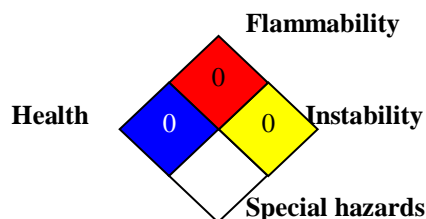
